UP ASSEMBLY ELECTIONS – 2007 (PHASE – I)

प्रेस विज्ञप्ति

उ०प्र० विधानसभा 2007 चुनाव (प्रथम चरण) के परिप्रेक्ष्य में प्रेस क्लब, लखनऊ में दिनांक 29 मार्च 2007 को **उ० प्र० इलैक्शन वाच (UPEW)** एवं एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स (ADR) के संयुक्त तत्वाधान में एक प्रेस वार्ता आयोजित की गई। UPEW के संयोजक श्री ईश्वर चन्द्र द्विवेदी (सेवानिवृत्त पुलिस महानिदेशक उ०प्र०), ADR के अध्यक्ष प्र० त्रिलोचन शास्त्री तथा उ०प्र० इलैक्शन वाच के प्रवक्ता श्री पवन राणा ने पत्रकारों को संबोधित किया।

प्र० शास्त्री ने बताया कि सुप्रीम कोर्ट ने अपने 2 मई 2002 एवं 13 मार्च 2003 के फैसले में प्रत्येक उम्मीदवार को एक हलफनामे द्वारा अपने वित्तीय, शैक्षणिक और अपराधिक रिकार्ड (यदि कोई हो तो) की जानकारी देने के लिये बाध्य कर, मतदाता और नागर समाज को देश के राजनीतिक तंत्र में सुधार लाने में अपनी सक्रिय भूमिका अदा करने हेतु सक्षम बना दिया है।

श्री द्विवेदी ने बताया कि उत्तर प्रदेश इलैक्शन वाच राज्य के संवेदनशील नागरिकों का मंच है। यह एक निष्पक्ष तथा गैर-दलगत, नागरिक प्रयास है। इसका मुख्य उद्देश्य मतदाता जागरूकता, मतदाताओं को उम्मीदवारों के बारे में बेहतर जानकारी उपलब्ध कराना है। यह विशेषतः राजनीति में सक्षम, ईमानदार तथा जनसेवा में प्रबल रूचि रखने वाले नेतृत्व को आगे लाने का प्रयास है।

श्री पवन राणा ने प्रथम चरण के उम्मीदवारों के नामांकन के साथ शपथपत्रों के विस्तृत विश्लेषण पर आधारित उम्मीदवारों के बारे में अपराधिक मामले, चल-अचल संपत्ति तथा देनदारी संबंधी अत्यन्त चौकाने वाली जानकारी पत्रकारों के समक्ष रखी।

श्री द्विवेदी ने कहा कि उपरोक्त आँकड़ों से यह स्पष्ट होता है कि प्रमुख दलों द्वारा समय-समय पर साफ-सुथरी छवि वाले उम्मीदवारों को ही टिकट देने के वायदे ताक पर रख कर जघन्य अपराधों के लिये आरोपियों को निसंकोच टिकट देकर अपना उम्मीदवार बनाया है।

उ०प्र० इलैक्शन वाच की ओर से यह माँग है की गयी कि आगामी चरणों में राजनैतिक दल सक्षम, ईमानदार तथा जनसेवा में प्रबल रूचि रखने वाले उम्मीदवारों को टिकट देंगे।

यह रिपोर्ट उ० प्र० विधानसभा चुनाव 2007 (प्रथम चरण) के सभी 785 अभ्यर्थियों द्वारा नामांकन के साथ प्रस्तुत किये शपथपत्रों से ली गयी जानकारी पर आधारित है।

रिपोर्ट का सार संक्षेप

कुल 785 उम्मीदवारों में से

- 131 (16.69 %) के खिलाफ अपराधिक मामले लम्बित हैं। इनमें से 18 उम्मीदवार हत्या, 52 हत्या के प्रयास, 60 जान से मारने की धमकी एवं 24 उम्मीदवार धोखाधड़ी में आरोपित हैं। इस श्रेणी में सबसे आगे है बसपा 22/62 (35 %), सपा 19/61 (31 %) भाजपा 16/54 (30 %)।
7 निर्वाचन क्षेत्र ऐसे हैं जिन्हें अपराध के मामले में अति संवेदनशील कहा जा सकता है। इन क्षेत्रों में 5 से लेकर 9 उम्मीदवारों तक के खिलाफ अपराध के मामले दर्ज हैं।
- 11 उम्मीदवार ऐसे हैं जिनके अपराधिक मामलों का उल्लेख इलाहाबाद उच्च न्यायालय याचिका संख्या 5695/2006 (करण सिंह बनाम उत्तर प्रदेश राज्य एवं अन्य) के आदेश में तो है लेकिन उनके द्वारा दायर हलफनामों में इन मामलों का कोई जिक्र नहीं है।
- 509 उम्मीदवारों (65 %) के पास PAN नहीं है अथवा उन्होंने हलफनामे में यह दर्शाना उचित नहीं समझा।
- एक करोड़ से अधिक संपत्ति वाले 74 उम्मीदवार हैं। इनमें सबसे आगे है सपा 17/61 (28 %), भाजपा 14/54 (26 %) और फिर बसपा 14/62 (23 %)।
- प्रमुख राजनीतिक दलों के उम्मीदवारों की घोषित औसत संपत्ति में सबसे आगे है सपा 87.23 लाख, भाजपा की 79.32 लाख, काँग्रेस की 58.88 और बसपा की 55.02 लाख।

यह रिपोर्ट उ०प्र० इलैक्शन वाच के लिये ADR, PVCHR, ERA, परमार्थ, AIM, सहित अनेकों स्वैच्छिक संस्थाओं एवं सामाजिक कार्यकर्ताओं का संयुक्त प्रयास है।

The Supreme Court judgments of 2 May 2002 and 13 March 2003 mandating disclosure of criminal records (if any), financial and educational information by all candidates has empowered the Voter and the Civil Society to actively participate in improving the quality of polity and governance in our country.

The **U.P. Election Watch** (UPEW) is a non-partisan civil society effort at creating accountable and transparent governance in the State. It is not aligned to any political party/ candidate. Main objective is to raise voter awareness to enable them make an informed choice before casting their vote. In particular, the entire effort is directed to ensure that the political parties put up public service oriented, capable and honest candidates.

The report is based on information of all the 785 candidates, contesting for Phase – I elections to the U.P. Assembly 2007.

SUMMARY OF FINDINGS

Out of the **total 785** candidates

- **131 (16.69%) candidates have criminal cases pending against them.** Of these 18 are charged with murder, 52 with attempt to murder, 60 with criminal intimidation and death threat, and 24 with forgery. In this category top three are BSP 22/62 (35%), SP 19/61 (31%) and BJP 16/54 (30%).
- **7 constituencies** can be considered as Red Alert ones, as each of these constituencies have 5 to 9 candidates charged with criminal offences.
- There are **11 candidates** enlisted in Allahabad High Court Order writ petition No. 5695/ 2006 (*Karan Singh V/s State of Uttar Pradesh*) but they have not made any mention in the affidavits filed by them along with their nominations.
- In all **509 (65 %) candidates** either **do not have PAN** or they have been reluctant in mention it in their affidavits. Among political parties INC leads with 35.48%, BSP 32.25%, SP 31.14% and BJP 24.07 %.
- There are **74 candidates having assets worth more than Rs.1 Crore.** SP leads the category with 17/ 61 (28 %), followed by BJP 14/54 (26 %) and BSP 14/ 62 (23 %).
- Among the major political parties, **average declared assets** of SP candidate are worth Rs.87.23 Lakh, BJP 79.32 Lakh, INC 58.88 Lakh, and BSP 55.02 Lakh.

ADR (Association for Democratic Reforms), PVCHR, ERA, PARMARTH, AIM, and number of NGOs and Social activists have collectively worked for 'U.P. Election Watch' to bring out this Report.
