

U.P. ELECTION WATCH U P ASSEMBLY ELECTIONS – 2007 (PHASE – II)

उ0प्र0 इलैक्शन वाच राज्य में स्वच्छ राजनीति एवं पारदर्शी शासन के लिये एक निष्पक्ष नागरिक पहल है।

इलैक्शन वाच ने अभ्यर्थियों द्वारा नामांकन के प्रस्तुत शपथ-पत्रों का एकत्रीकरण तथा उनका विश्लेषण कर, मतदाता के लिये महत्वपूर्ण जानकारी को सुगम व पठनीय बनाया है। दूसरे चरण तक की जानकारी एक संक्षिप्त रिपोर्ट के रूप में 9 अप्रैल को उ0प्र0 प्रेस क्लब लखनऊ में मीडिया व अन्य संस्थाओं के समक्ष प्रस्तुत की गयी। यह रिपोर्ट समान्तर रूप से राज्य भर में अनेक स्थानों पर भी रिलीज़ की गयी।

इस जानकारी का राज्य भर में व्यापक वितरण करने में हम आपसे सहयोग की अपेक्षा रखते हैं।

उ0 प्र0 विधानसभा चुनाव 2007 (द्वितीय चरण) के अर्न्तगत राज्य के पश्चिमी भाग के 10 जिलों के 58 निर्वाचन क्षेत्र आते हैं, जो कि कुल निर्वाचन क्षेत्रों का 14.39 प्रतिशत है।

इन जिलों की कुल जनसंख्या 2.43 करोड़ है (राज्य की कुल जनसंख्या का 14.62 प्रतिशत)। इस चरण में राज्य का सर्वाधिक आबादी वाला निर्वाचन क्षेत्र गाजियाबाद (निर्वाचन क्षेत्र सं0 373) भी 13 अप्रैल को मतदान करेगा जिसमें अनुमानित 7.61 लाख मतदाता हैं।

दूसरे चरण में 860 अभ्यर्थी हैं, जिनमें से 279 प्रमुख राजनीतिक दलों से, 179 अन्य दलों से, तथा 402 निर्दलीय हैं। प्रत्येक निर्वाचन क्षेत्र से औसत 14.86 उम्मीदवार मैदान में हैं, जो 2002 के विधानसभा तथा 2004 के लोकसभा चुनावों से कहीं अधिक है।

उ0प्र0 इलैक्शन वाच ने 792 प्रत्याशियों के शपथपत्रों का विश्लेषण किया। शेष कुछ एक निर्दलियों का विश्लेषण इसमें सम्मिलित नहीं हो पाया क्योंकि उनके शपथ-पत्र या तो रिक्त थे अथवा ठीक से स्कैन ही नहीं थे।

रिपोर्ट का सार संक्षेप

792 में से मात्र 30 (3.78 प्रतिशत) महिला उम्मीदवार हैं। इन 10 जिलों में लिंगानुपात देश में सबसे कम है। शासन में महिलाओं की भागीदारी सुनिश्चित करने के लिये एक विधेयक की निरंतर माँग के दौर में यह एक दुर्भाग्यपूर्ण सूचक है।

कुल 792 उम्मीदवारों में से

- 102 (12.88 %) के खिलाफ अपराधिक मामले लम्बित हैं।

इनमें से सबसे अधिक हैं बसपा में 18/58 (31%), फिर क्रमवार हैं भाजपा 14/57 (24%), रालोद 11/51 (22%), सपा 12/56 (21%), और काँग्रेस 9/57 (16%)।

यदि हम राजनीतिक दलों के उम्मीदवारों का समूचे रूप से प्रतिशत देखें तो पहले और दूसरे चरण में सबसे आगे है बसपा 33%, फिर है भाजपा 27%, सपा 26%, और काँग्रेस 20%। इस प्रकार प्रमुख राजनीतिक दलों का यह औसत लगभग 25 प्रतिशत आता है। अर्थात् राजनीतिक दलों के 4 में 1 प्रत्याशी के खिलाफ अपराधिक मामले लम्बित हैं।

- 14 उम्मीदवार ऐसे हैं जिनके अपराधिक मामलों का उल्लेख इलाहाबाद उच्च न्यायालय याचिका संख्या 5695/2006 (करण सिंह बनाम उत्तर प्रदेश राज्य एवं अन्य) के आदेश में तो है लेकिन

उनके द्वारा प्रस्तुत हलफनामों में इन मामलों का कोई जिक्र नहीं है। इनमें से कुछ एक प्रमुख राजनीतिक दलों से भी हैं – भाजपा व बसपा से 3-3 एवं सपा व रालोद से 2-2 हैं।

- भाजपा के 1 तथा बसपा के 1 प्रत्याशी के अलावा बाकी ने उ0प्र0 सरकार के आँकड़ों से भिन्न आँकड़े उद्घोषित किये हैं। इस सूची में 5 उम्मीदवार ऐसे भी हैं जिन्होंने कोई भी अपराधिक मामला लम्बित न होना घोषित किया है, लेकिन सरकारी दस्तावेज में उनके खिलाफ गंभीर मामले दर्ज हैं। इनमें से रालोद, सपा व बसपा, प्रत्येक से एक एक उम्मीदवार है।
- इस श्रेणी में अपराधिक मामलों की संख्यानुसार सर्वोच्च 10 उम्मीदवारों में से पहले नम्बर पर बसपा के अमरसिंह यादव (सिकन्दाराव 354) के 11 मामले लम्बित हैं। इस सूची में बसपा के 4 प्रत्याशियों के नाम आते हैं।
- सरकारी दस्तावेज के अनुसार खेकड़ा (384) से रालोद के उम्मीदवार मदन भैया के खिलाफ 59 अपराधिक मामले लम्बित हैं। इसके बाद हैं मोरना (391) से बसपा के राजपाल सिंह सैनी 26 मामले और हाथरस (352) से बसपा के ही रामवीर उपाध्याय के 12 मामले।
- **6 निर्वाचन क्षेत्र** ऐसे हैं जिन्हें अपराध के मामले में **अति संवेदनशील** कहा जा सकता है। इन क्षेत्रों में 4 से लेकर 6 उम्मीदवारों तक के खिलाफ अपराधिक मामले दर्ज हैं। ये हैं – गंगीरी (355), सिकन्दराबाद (370), मथुरा (347), हाथरस (352), मोरना (391), और थानाभुवन (396)।

मतदाता के लिये दो शब्द सावधानी के

लम्बित अपराधिक मामलों वाली सांसदों की सूची में उ0प्र0 सबसे आगे है (80 में से 21)। गतवर्ष देश में हत्या और जघन्य अपराधों के संख्या में उ0प्र0 सबसे आगे था। इनमें से 30 प्रतिशत अपराध दूसरे चरण का मतदान करने वाले 10 जिलों में दर्ज हैं। 2002 के विधानसभा चुनावों में अपराधिक पृष्ठभूमि के 506 उम्मीदवार मैदान में थे, जिनमें से 206 (51.11 प्रतिशत) विधायक भी बने। अर्थात् प्रत्येक दूसरा विधायक अपराधिक पृष्ठभूमि से था।

- एक करोड़ से अधिक संपत्ति घोषित करने वाले **126 (16%) उम्मीदवार** हैं। इनमें से प्रमुख दलों में सबसे आगे है बसपा 29/58 (50%), रालोद 20/51 (39%), भाजपा 20/57 (35%), सपा 19/56 (34%) और काँग्रेस 12/57 (21%)।
- सर्वोच्च 10 में प्रमुख राजनीतिक दलों के उम्मीदवारों की घोषित औसत संपत्ति में से 3 सपा, बसपा और भाजपा प्रत्येक से 2, काँग्रेस, रालोद व बी0के0डी0 से 1 प्रत्येक।
- इस चरण में प्रमुख राजनीतिक दलों के उम्मीदवारों की घोषित औसत संपत्ति में काफी बढ़त नजर आती है। इस सूची में सबसे आगे है सपा 1.64 करोड़, बसपा 1.36 करोड़, भाजपा 1.15 करोड़, रालोद 1.12 करोड़ और काँग्रेस 0.97 करोड़।

चुनावी परिप्रेक्ष में धनबल की भूमिका स्पष्ट है, जो चुनावी मैदान को असमतल बना देता है।

- इस चरण में पार्टी के उम्मीदवारों की औसत देनदारी भी काफी रोचक है। प्रमुख राजनीतिक दलों में सबसे उपर है काँग्रेस जिसकी औसत देनदारी है 9.44 लाख, सपा 6.57 लाख, भाजपा 6.45 लाख, रालोद 4.57 लाख, और बसपा 4.57 लाख।

कुल 792 अभ्यर्थियों में से 509 उम्मीदवारों (65%) के पास PAN नहीं है

- प्रमुख राजनीतिक दलों में से रालोद के 45%, काँग्रेस के 42%, भाजपा 40%, सपा 37%, और बसपा के 36% उम्मीदवारों के पास PAN नहीं है।

जब हम 1 करोड़ से अधिक की संपत्ति घोषित करने वाले उम्मीदवारों की सूची पर नजर डालते हैं तो पाते हैं कि बसपा के 10 उम्मीदवार, सपा एवं रालोद प्रत्येक के 5, भाजपा के 3, काँग्रेस के 2 और जनमोर्चा के 1 उम्मीदवार के पास PAN नहीं है।

इसी प्रकार अधिक देनदारी वाले उम्मीदवारों की सूची पर नजर डालते हैं तो उसमें बसपा के 4 उम्मीदवार, भाजपा एवं काँग्रेस के 2 प्रत्येक, तथा सपा एवं रालोद के 1-1 उम्मीदवार के पास PAN नहीं है।

देनदारी वाली सर्वोच्च 10 की सूची में मुजफरनगर (392) से काँग्रेस के सैद्दूजमान का नाम सबसे उपर है। चौकाने वाली बात है कि 2 करोड़ से अधिक के ऋण के बावजूद भी वे PAN रहित है।

जब हम उम्मीदवारों का शैक्षणिक स्तर देखते हैं तो राजनीतिक दलों के उम्मीदवारों की शैक्षणिक योग्यता में अच्छी-ख़ासी बढ़त पाते हैं। स्नातक व उससे अधिक योग्यता वाले उम्मीदवारों की संख्या में सबसे आगे है भाजपा 68%, फिर है काँग्रेस 59%, सपा 50% और बसपा 45%।

इसी प्रकार राजनीतिक दलों ने अपेक्षाकृत कम उम्र के उम्मीदवारों को वरीयता दी है। प्रमुख राजनीतिक दलों लगभग 90 प्रतिशत उम्मीदवार 60 वर्ष से कम आयु के हैं। इस श्रेणी में अधिकतम 41-60 वर्ष की आयुवर्ग के हैं।

शपथ-पत्रों का एकत्रीकरण, उनमें से महत्वपूर्ण जानकारी निकाल कर, मतदान से पहले मतदाताओं में उसका व्यापक वितरण करना, आदि सभी स्वैच्छिक प्रयास हैं। इसका मुख्य उद्देश्य मतदाता जागरूकता, मतदाताओं को उम्मीदवारों के बारे में बेहतर जानकारी उपलब्ध कराना है। ज्ञात रहे कि लोकतंत्र में नागरिक से बड़ा कोई पद नहीं होता।

यह रिपोर्ट **उ0प्र0 इलैक्शन वाच** के लिये ADR, PVCHR, ERA, परमार्थ, AIM, सहित, 200 से भी अधिक स्वैच्छिक संस्थाओं एवं सामाजिक कार्यकर्ताओं का संयुक्त प्रयास है।

The U.P. ELECTION WATCH is a non-partisan civil society initiative at creating accountable and transparent governance in the State.

The U.P.E.W. collected the affidavits presented by candidates along with their nomination papers and analyzed them for better comprehension by the Voter. Details of findings up to the 2nd phase nominations were released to the Media and other Civil Society organizations on the 9th of April at the U.P. Press Club Lucknow and simultaneously at other places in the state.

We solicit your cooperation in disseminating candidate background information throughout the State.

Summary Note

The second phase of UP Assembly Elections 2007 covers 58 constituencies, falling under 10 districts of western part of the state. These districts (14.39% of total number of constituencies) have a total population of 2.43 crore (14.62% of the state's total population). In this phase, Ghaziabad (const # 373) the most populous constituency in the state, with an estimated electorate of 7.61 lakhs, goes to polls.

In phase II there are 860 candidates in the fray, with 402 Independents, 179 belonging to minor political parties and 279 belonging to major political parties. The average number of candidates contesting per constituency is 14.86, much higher than the average for the 2002 Assembly and 2004 Parliamentary elections in the state.

The UP election watch took into consideration **792** candidates leaving out some independents whose affidavits were either blank or badly scanned.

Findings:

- There are 30 (3.78%) women candidates out of the 792 taken into account.

The sex ratios in these 10 Districts are the worst in the country. In an era of demand for progressive legislation to secure women's participation in governance, this is an unfortunate indicator.

- Out of 792 candidates, 102 have pending criminal cases against them.

BSP leads the list of such candidates with 18 out of 58 (31.03%), followed by BJP, 14 out of 57 (24.56%), RLD, 11 out of 51 (22%), SP, 12 out of 56 (21.43%) and INC, 9 out of 57 (16.07%).

If we consider the combined percentage of candidates fielded by main political parties, in phase 1 and 2, BSP leads the pack with 33.33%, followed by BJP—27.03%, SP—26.50%, and INC—20.17% This brings the overall percentage of such candidates fielded by main parties to 25.65%, that is, one in four candidates put up by major political parties has pending criminal cases against him/her.

There are 14 candidates who were members of the previous Assembly and according to the affidavit submitted by the UP Home Secretary to the High Court, had pending criminal cases against them. Among the major parties BJP and BSP account for 3

each and RLD and SP for 2 each of such candidates. Apart from one BJP and one BSP candidate, the rest have stated figures in their current affidavits, which are different from the UP Govt.'s affidavit figures. There are 5 candidates in this list who have declared that they have no pending criminal cases, but according to the Govt affidavit have serious cases pending against them. RLD, SP, and BJP account for one each in this category.

- The top ten list of candidates, arranged according to number of cases, is headed by Amar Singh Yadav of BSP, contesting from Sikandra Rao (354), with 11 pending criminal cases. BSP has 4 candidates who have made it to this list.
- According to the Govt affidavit, Madan Bhaiya of RLD, contesting from Khekra (384) has 59 pending criminal cases against him, followed by Rajpal Singh Saini of BSP (Morna-391) with 26 cases and Ramvir Upadhyay (Hathras-352), of the same party with 12 pending cases.
- There are six constituencies, which have 4 or more candidates with pending criminal cases. These are, Gangiri (355) 6, Sikandarabad (370) 5, Mathura (347) 4, Hathras (352) 4, Morna (391) 4, and Thana Bhuwan (396) 4. The high number of candidates with criminal cases pending constrains the Voter's choice. But it is the voter who has to find a way out.

A note of caution for the voter

UP leads the list of parliamentarians with pending criminal cases (21 out of 80) in the country. UP also leads in the statistics of murder and violent crimes committed in the country in the past year. The 10 Districts going to polls in the second phase account for about 30% of such crimes with 14.62% of the state's total population. During the assembly elections in 2002, there were 506 candidates in the fray, with pending criminal cases against them. Out of these, 206 became MLAs. This means 51.11% of the previous assembly members, that is, every second member in that house, had pending criminal cases against him or her.

- There are 126 candidates (15.91%) who have declared assets worth more than a crore.
- Among the major parties, BSP has 29/58(50%), RLD, 20/51(39.22%) BJP, 20/57(35.09%), SP, 19/56 (33.93%), and INC, 12/57 (21.05%) candidates who are Crorepatis.
- In the top ten list, arranged according to declared total wealth, 3 SP, 2 each from BSP and BJP, and one each from INC, RLD and BKD candidates make the cut.
- Average assets of a main party candidate have gone up sizably in this phase. The list is topped by SP with an average declared asset worth Rs 1.64 Crores, followed by, BSP, Rs. 1.36 Crores, BJP, Rs.1.15 Crores, RLD, Rs. 1.12 Crores, and INC, Rs. 0.97 Crores.

The role of money power in the electoral arena is very distinct. This makes the contest uneven.

- The top ten list of high liabilities is headed by the INC candidate from Muzaffarnagar (392), Saiduzzaman. Interestingly, though his loans are more than Rs.2 crores, he does not possess PAN.
- In this phase the average liability of a party candidate makes interesting reading. Among the major political parties, INC heads the group with an average liability of Rs 9.44 lakhs, followed by SP, Rs 6.57 Lakhs, BJP, 6.45 Lakhs, RLD, 4.57 Lakhs, and BSP, Rs 4.57 lakhs.
- There are 509 candidates out of 792 (64.27%) who do not have PAN.
- Among the major political parties, RLD has 45.10% candidates, INC, 42.11%, BJP, 40.35%, SP, 37.50%, and BSP, 36.21% candidates who do not have PAN.
- Interestingly, when we look at the list of candidates who have declared assets worth more than a crore, we find that, 10 BSP candidates, 5 each from SP and RLD, 3 BJP, 2 INC and 1 Janmorcha candidate do not have PAN.
- Similarly, when we look at the list of candidates with high liabilities, 4 BSP, 2 each from BJP and INC, and 1 each from RLD and SP do not possess PAN.
- When we look at the educational; profile of candidates, we see that there is a marked increase among major political parties in putting up candidates who are highly educated. BJP leads the list with 68.42%, followed by INC, 59.65%, SP, 50%, and BSP, 44.83% candidates who are graduates and above.
- Similarly, there is a marked preference by main political parties for candidates who are younger. Almost 90% candidates belonging to main political parties are below 60 years of age. And the bulk belongs to the category between 41-60.

Collection of affidavits, collation of information contained there in, and dissemination among voters of this information before the voting day are voluntary civil society efforts. This is intended to enable the voter to make an informed and responsible choice while casting their votes. It is to be remembered that in a democracy there is no position higher than that of the CITIZEN.

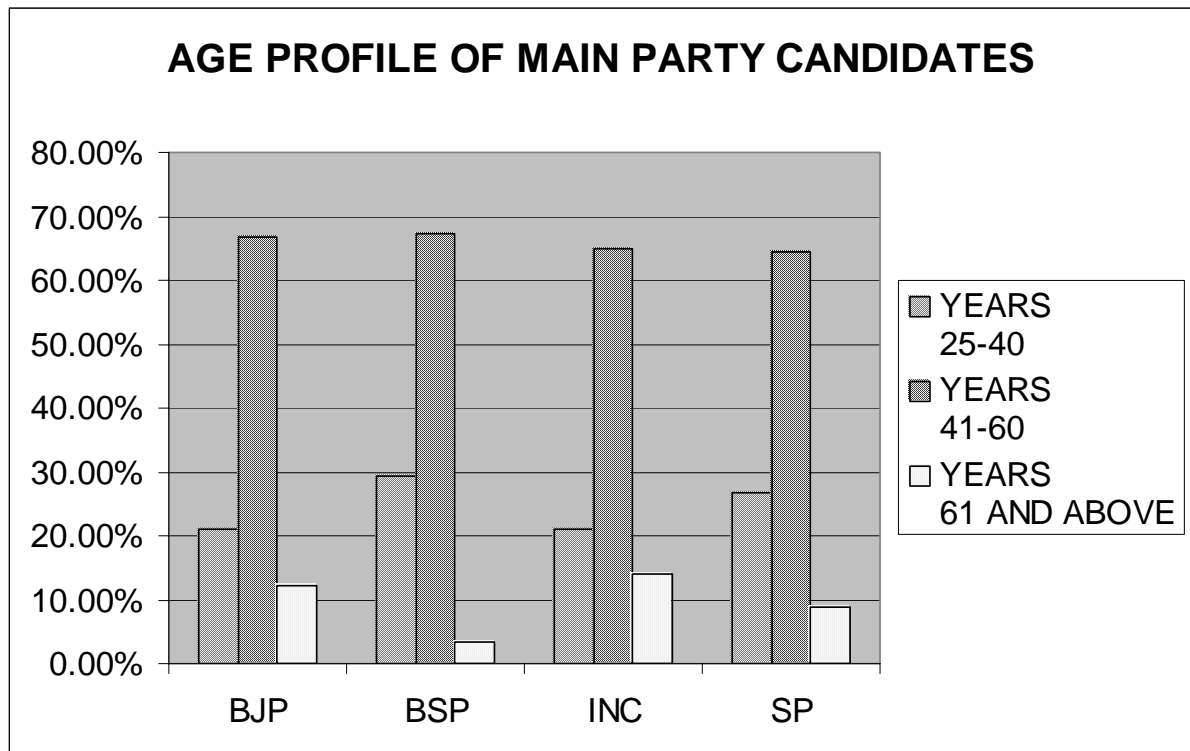

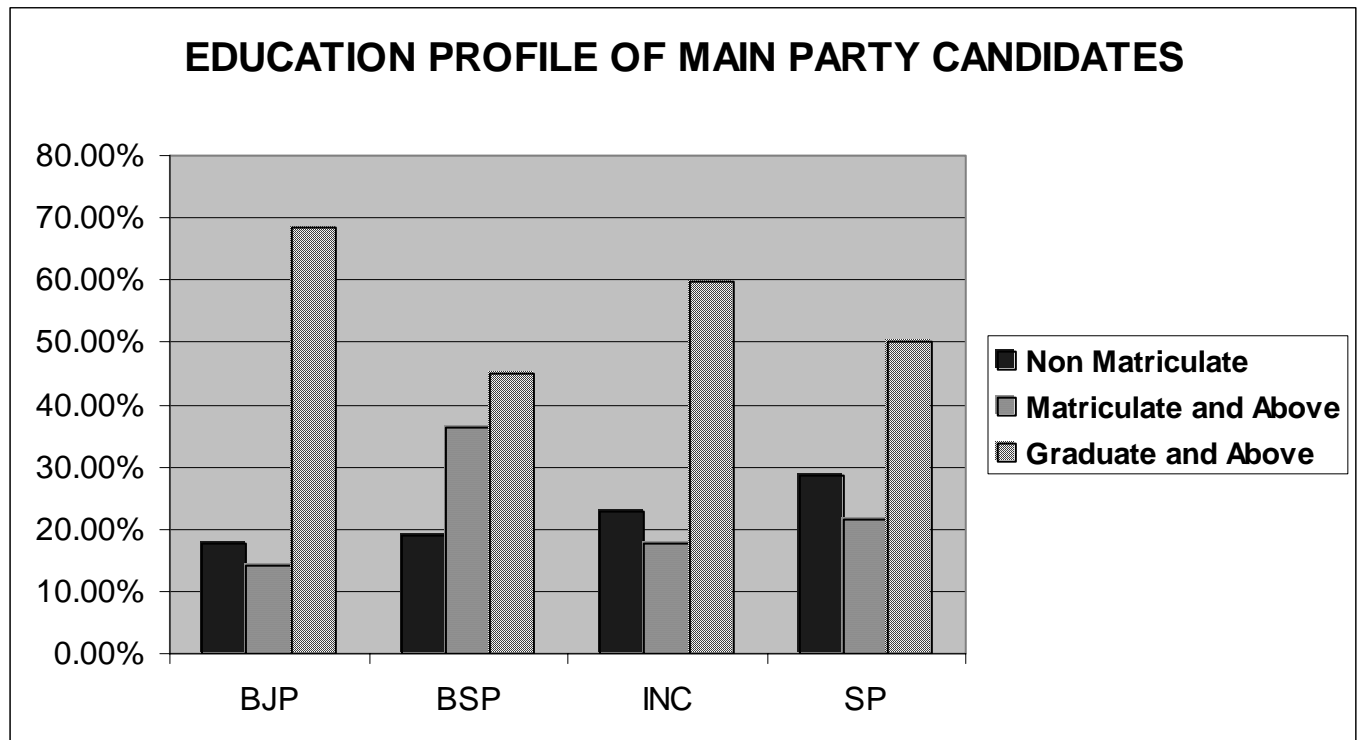

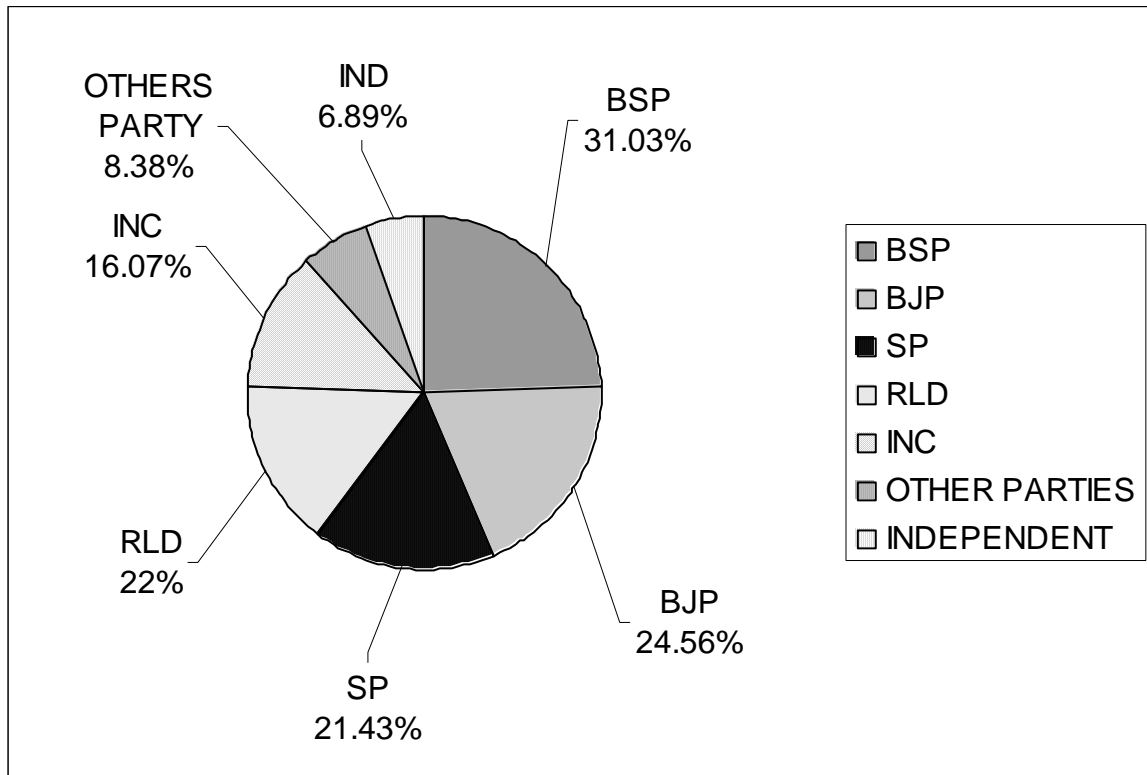
