The U.P. ELECTION WATCH is a non-partisan civil society initiative at creating accountable and transparent governance in the State. The U.P.E.W. collected the affidavits presented by candidates along with their nomination papers and analyzed them for better comprehension by the Voter. Details of findings up to the 3<sup>rd</sup> phase nominations were released to the Media and other Civil Society organizations on the 14<sup>th</sup> of April at Lucknow and simultaneously at other places in the state.

We solicit your cooperation in disseminating candidate background information throughout the State.

The Third phase of UP Assembly Elections-2007 covers **57** constituencies, falling under 10 districts of north-western part of the state. These districts, with a total population of 2.42 crore (14.56% of State's total popn), account for 14.14% of total number of constituencies and 20 % of the reported crime.

In this phase, there are 1.51 Crore electors, suppose to go for Poll on 18<sup>th</sup> of April.

UP Election Watch has taken into consideration **859** candidates. There are 273 candidates fielded by major political parties, 231 by smaller parties and 355 are independents.

### Main findings:

- There is an increase in no. of women candidates in this phase. There are in all **50** women candidates (5.82%) in the fray in the third phase.
- There are **118** candidates who have pending criminal cases against them. Among the major political parties SP has **20** out of 56 (35.71%), BSP, **17** out of 57 (29.82%), BJP, **15** out of 51 (29.41%) INC, **13** out of 56 (23.21%) and RLD **9** out of 53 (16.98%) such candidates in the fray. There are 26 candidates with pending cases among the smaller political parties and 18 amongst the independents.
- There are **23** candidates who were members of the outgoing assembly and had pending criminal cases against them. Out of these 18 candidates have not mentioned about these cases in their current affidavits.
- In **8** constituencies each have more than 4 candidates having pending criminal cases against them. These are: Amroha – 6 candidates, Bareilly Cant - 6; Bilaspur - 5; Dadraul - 5; Moradabad –5; Nawabganj - 4; Rampur - 4; Sunha – 4 candidates.
- **60** candidates have declared assets worth more than Rs 1 Crore.  
SP leads the list with 14, BSP-10, INC-9, BJP-6 and RLD-4. The INC candidate from Puranpur (const.44) is the richest with a declared asset of Rs. 374.80 Crores. Accordingly the average candidate asset, the list is led by INC for the third phase.
- There are **626** candidates out of 859 (72.88%) who either do not have PAN or have not mentioned it. RLD leads the list with 67.92% of such candidates. Among the smaller parties 83.98% candidates have not given PAN. Among these LJP has 7 out of 8 (87.50%); IJP has 13 out of 15 (86.66%); Jan Morcha, 11 out of 13 (84.61%), RJD, 10 out of 12 (83.33%); and Lokdal 13 out of 16 (81.25%).

18 candidates, with liability of more than Rs 4 lakhs, do not have PAN.

The area exhibits population density of 686 persons per sq.km with almost 77% of rural population. Sex-ratio (868 women/'000 men) and literacy (50.87 %) are far below than that of the state.

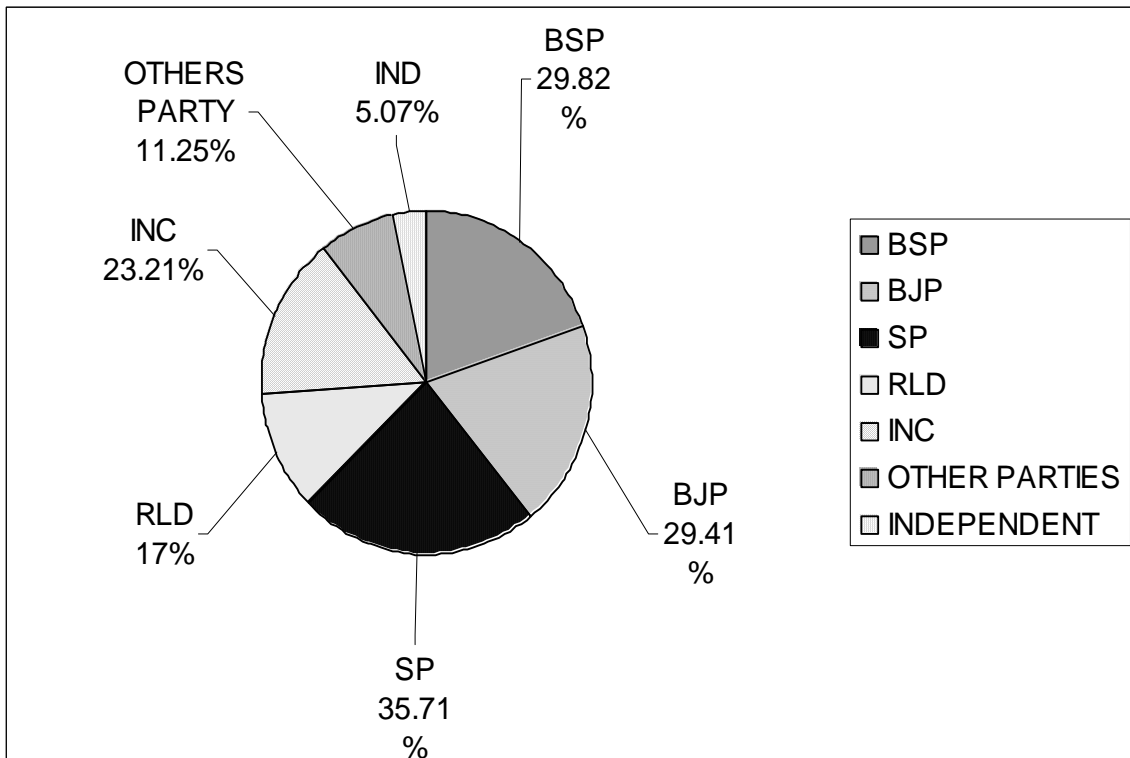
